CONDITIONS:

1. All new membership applicants will be granted the status of Provisional membership whilst awaiting the decision of the Board for election as a Social member of the Club.
2. Should a person who is admitted as a Provisional member not be elected to Social membership of the Club, for any reason, within 6 weeks from the date of application, the person shall cease to be a member of the Club and all fees paid will be refunded to the applicant. The Board will notify any unsuccessful applicants in writing. Any unredeemed Wests Member Loyalty Points for unsuccessful applicants will be forfeited.
3. Any unredeemed points accumulated as a result of any business activity through Wests Member Loyalty Programs will be forfeited on the close of trading on 31st October each year. Members are encouraged to redeem their points anytime prior to this date each year.
4. Application for General membership is only available to Social members who have held membership with the Club for a continuous period of no less than 3 years. General membership is subject to approval by the Board of Directors.
